



Better Hearing Australia Scholarship

2018 TERMS AND CONDITIONS

WHAT THIS SCHOLARSHIP PROVIDES

The Better Hearing Australia Scholarship for 2018 will provide the following:

\$1,000 AUD cash payment each semester to assist with costs associated with studying (text books, incidental expenses etc.) for the 2018 school year, in which the scholarship is offered.

If you receive a Centrelink payment, you should declare to Centrelink any scholarships you are awarded.

The Australian Taxation Office has a "Is your scholarship taxable?" tool on their website to help you determine if your scholarship is taxable. For expert advice please contact the Australian Taxation Office or your accountant.

CONDITIONS THAT NEED TO BE MET TO KEEP YOUR SCHOLARSHIP

To retain eligibility for a Better Hearing Australian Scholarship all students must:

1. Unless there are exceptional circumstances

- Remain in initial course of study;
- Maintain enrolment as outlined in your application of 100 credit points each semester at the University. If any study is undertaken below 100 credit points in a semester, you are required to seek approval for this change from the President, Better Hearing Australia.
- Maintain address details and advise Better Hearing Australia in any changes in circumstances within 14 days.
- Be available for promotional interviews / photographs to promote Better Hearing Australia.

Unless there are **exceptional circumstances** a recipient with unsatisfactory progress or who breaches the scholarship conditions shall be ineligible to retain the scholarship.

Exceptional circumstances must be forwarded to and shall be at the discretion of the President, Better Hearing Australia. Supporting original documentation (eg medical, counselling) must be provided.

PAYMENT OF SCHOLARSHIP

The scholarship shall commence from Semester 1, 2018.

Two CHEQUE payments of \$1,000 will be sent to the student's nominated address.

First and second semester payments will occur post census dates (thus approx. mid-end April and mid-end September).
